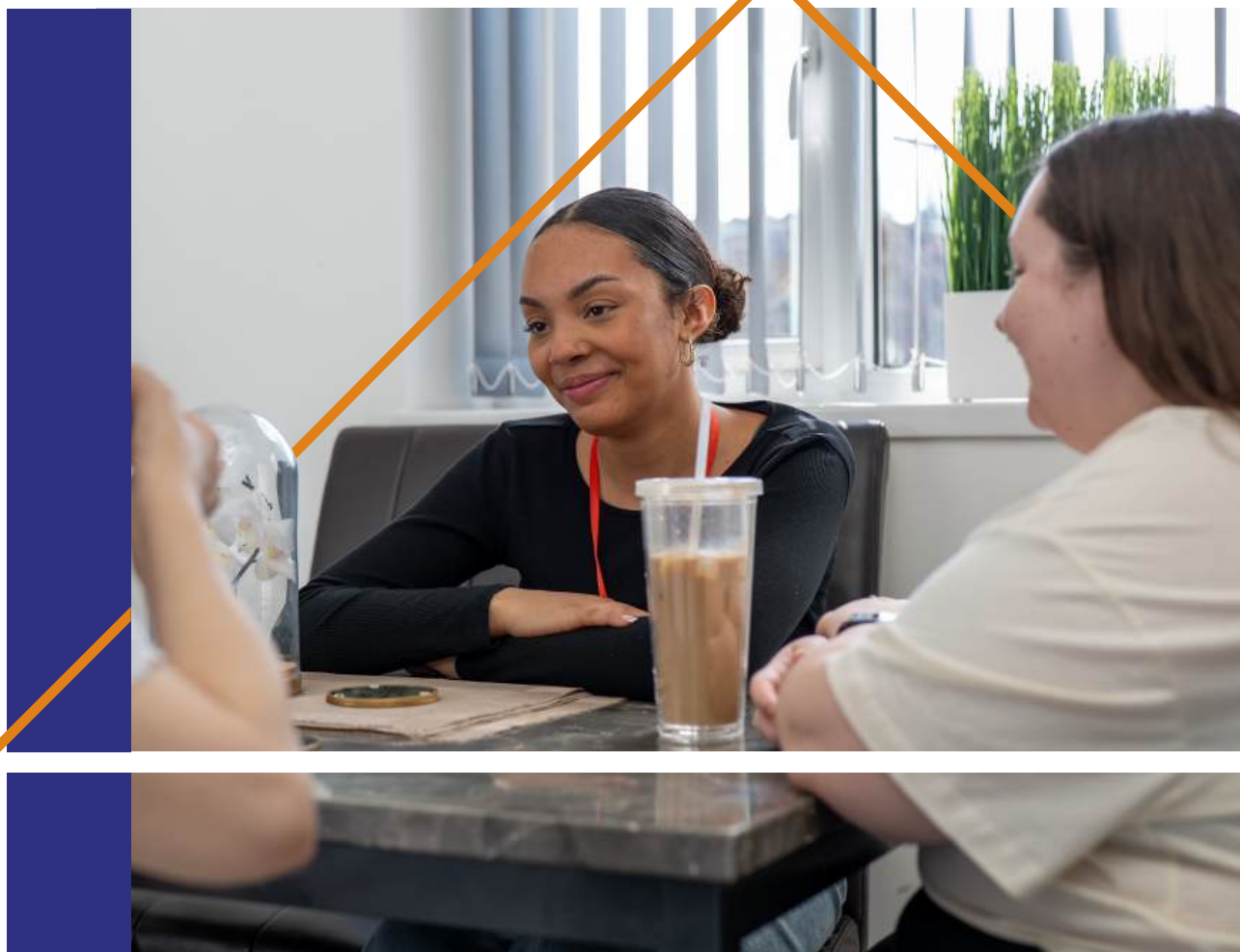

Prosperity Housing Group (PHG) is a CQC-registered Supported Living provider for adults aged 18 to 65 years old who have a diagnosed mental health condition, learning disability, autism, or dual diagnosis and who require care and housing support, but do not need to be in inpatient care.



We bridge the move from a residential or hospital setting to supported living providing the safe, therapeutic, and person-centred environment that people need to rebuild their lives, develop independence, and recover.

We recognise that people living with mental health conditions can find it profoundly challenging to live alone, manage day-to-day tasks, and maintain stable housing. Our service exists to address those challenges not just as a place to live, but as a genuine pathway to independence and community life.



OUR MISSION

To empower service users with long-term complex conditions to receive specialist care in a supported therapeutic home environment, preventing crisis escalation, accelerating recovery, and enabling people to live as independently as possible.

- Promoting integrated discharge planning — collaborating with hospital services, GPs, public health nurses, and other professionals

- Reducing lengthy hospital stays and preventing readmission

WHO WE SUPPORT & OUR SECTION 117 SERVICE

WHO WE SUPPORT

Prosperity Housing Group supports men and women aged 18 to 65 with a wide range of complex needs, including:

Mental Health Conditions (Primary Support Need)

- Schizophrenia and psychotic disorders
- Eating disorders (including anorexia nervosa and bulimia nervosa)
- Emotionally unstable / borderline personality disorder (EUPD/BPD)
- Complex and other personality disorders
- Bipolar affective disorder
- Obsessive compulsive disorder (OCD)
- Atypical and treatment-resistant depression
- Attachment disorder
- Complex trauma and PTSD
- Dual diagnosis (mental health and substance use)

ADDITIONAL SUPPORT NEEDS:

- Learning disabilities and/or autism with co-occurring mental health conditions
- Behaviour that challenges
- Adults involved in the criminal justice system or leaving prison with mental health conditions linked to offending or seriously irresponsible behaviour
- A history of long-term hospitalisation or risk of institutionalisation
- Medication support needs
- Financial support needs — budgeting, benefits, direct payments
- Activities of daily living support

WHAT IS SECTION 117 AFTERCARE

Section 117 of the Mental Health Act 1983 places a statutory duty, not a discretionary power on both the NHS Integrated Care Board (ICB) and the relevant Local Authority to provide or arrange aftercare for individuals discharged following detention under the Act.

Who Is Entitled to Section 117 Aftercare?

- Section 3 : Admission for treatment
- Section 37 : Hospital order (court-ordered)
- Section 45A : Hospital direction
- Section 47 : Transfer from prison - serving sentence
- Section 48 : Transfer from prison - remand prisoner

What Does Our Section 117 Aftercare Include?

Services that meet a need arising from or related to the person's mental disorder, reduce the risk of deterioration, and reduce the risk of readmission — including:

- Supported accommodation and 24/7 mental health support
- Medication management and monitoring
- Psycho-education and therapeutic interventions
- Daily living skills
- Crisis planning and prevention
- Social care, personal support, and community integration
- Employment, education, and social engagement support

At PHG, we provide commissioners with comprehensive, auditable evidence to support legally defensible aftercare decisions at every stage of the placement.

OUR SECTION 117 MODEL & THE PROSPERITY PATHWAY

HOW WE DELIVER SECTION 117 AFTERCARE

We are not a generic provider that happens to accept Section 117 referrals.

We are a specialist mental health supported living provider — built to deliver the evidenced based outcomes that Section 117 aftercare demands.

COMPREHENSIVE NEEDS ASSESSMENT

Every placement begins with a thorough, structured joint assessment, conducted with the referring hospital team, CMHT, ICB, and local authority, identifying mental health needs, risk factors, practical support needs, recovery goals, and any forensic or safeguarding considerations.

CARE PROGRAMME APPROACH (CPA) ALIGNMENT

All Section 117 service users are supported under the Care Programme Approach (CPA)
Every service user has:

- A designated Care Coordinator working alongside our team
- A comprehensive written Care Plan
- Regular CPA Reviews with all relevant parties
- A documented, reviewed Crisis Plan
- A maintained, shared Risk Assessment

THE PROSPERITY PATHWAY TO INDEPENDENCE

Our unique Prosperity Pathway Framework is a structured, step-by-step model that measures and develops the social, emotional, and practical capabilities our residents need to recover and live independently.

Each service user identifies key areas requiring development, and staff support them to set measurable, reviewed goals across:

EXAMPLES

Managing mental health: Self-awareness, medication management, crisis recognition

Managing physical health: Healthy eating, exercise, GP engagement

Self-care and self-love: Confidence, self-esteem, identity

Living skills: Cooking, cleaning, budgeting, tenancy management

Healthy relationships: Boundaries, communication, social skills

Education and employment: Training, literacy, community courses, career goals

Responsibility and independence: Decision-making, self-motivation, resilience

Goals are reviewed every 6 to 12 weeks — ensuring care is specific, measurable, and always focused on the individual's journey towards independence.



For Section 117 residents, the Pathway operates in full alignment with the CPA framework — ensuring that care planning, Pathway stages, and aftercare evidence are fully integrated and shared with commissioners.

INTEGRATED DISCHARGE PLANNING

Effective aftercare begins before discharge. We work closely with inpatient teams, discharge coordinators, CMHTs, ICBs, and local authorities to ensure:

- Placements are assessed, agreed, and ready before the individual leaves hospital
- There are no gaps in care at the point of discharge
- All parties are fully coordinated from day one
- Fast-track referral responses for urgent or complex discharges

FORENSIC AND PRISON SERVICE PATHWAY

We have specialist experience supporting individuals transferring from:

- Prison under Section 47 or Section 48 of the Mental Health Act
- Medium and low secure forensic units
- Courts via Section 37 Hospital Orders

We work proactively with MAPPA, probation, the prison service, and forensic CMHTs to ensure safe, structured, and legally compliant transitions into our supported living services.

Local Authority Commissioning Teams

Working with adult social care commissioners and mental health leads to arrange jointly funded placements and manage the full lifecycle of Section 117 aftercare - from assessment through to formal, evidenced discharge from aftercare.



Social Workers and Care Coordinators

Providing the day-to-day partnership, communication, and clinical collaboration that social workers and CMHTs need to manage complex cases with confidence — including regular reports, CPA attendance, and responsive communication.



Prison Service and Probation

Supporting safe, planned transitions from prison — including Section 47 and Section 48 transfers — with full MAPPA engagement, risk management expertise, and forensic pathway experience.



Courts and Legal Representatives

Providing specialist supported living placements for individuals subject to Section 37 Hospital Orders and related disposals.

Step 1

Step 2

Step 3

Full Assessment: Comprehensive joint assessment with the referring team, ICB, local authority, and individual.

Step 4

Care Plan & Agreement: Draft Section 117 Care Plan developed, placement terms agreed with commissioners, start date confirmed.

Step 5

Transition: Safe, supported, fully documented transition from hospital or prison to our service.

Step 6

Ongoing Support: Regular outcome reports, CPA attendance, and full commissioner communication throughout.
